E-statements are free and easy to use. Your statements are securely stored online and accessible anytime from any Internet-connected computer. You can access over two years of statements and even receive new statements a few days early.

It's easy to switch. Visit SunWestFCU.org and sign into Online Banking. Then click on the Online Statements tab on the red bar at the top of the page.

Make the switch to e-statements by August 21st and we'll deposit \$5 into your account. Consider it another benefit to banking with SunWest.
